Infrastructure will be resolved in new hospital building.

Due to deficit of faculties available in Shalyatantra department, presently OT is seems to be non-functional but some minor OT procedures are carried out. As soon as faculties will be available in concerned department OT will be fully functional.

Majority of Patients are coming for Antenatal care in hospital. Labour room is available in old hospital building. Equipped labour room with all ultramodern facility will be constructed in new hospital building. Civil hospital and medical college is in close proximately of this institute so presently patients preferring to go in nearby Govt. civil Hospitals.

As soon as proper infrastructure for radiological investigation developed in new Hospital Building and trained staff recruited we will start USG facility. Presently we have MOU with outside radiological centre USG.

Agadtantra OPD is functional since past 2 years. Records are available. Bed distribution in IPD for Agadtantra Dept. is done as per MES 2024.

In Kaumarbhritya & SRPT dept. patient are regularly admitted in IPD. On the day of visitation IPD patient in said dept. are available on day care basis. As per MES 2024 there is provision to admit patient through Day care and counted in IPD /Bed Occupancy.

We have adequate number of qualified pharmacist available in institute as per MSR 2016 & MES 2024. Due to large number of OPD patients daily Mr. Umang Rathod is only assisting in dispensing. He can be counted as other hospital staff category. (Annexure- 3)

At present Clinical Registrar post is vacant in hospital. Work of clinical registrar is look after by person having graduate degree in medical profession. The said doctor has graduate degree in medical profession and look after clinical registrar work temporary. (Annexure- 4)
